

INFORMATION ON THE PROCESSING OF PERSONAL DATA

Pursuant to and for the purposes of art. 14 of the EU Reg. 2016/679 and national legislation in force

METHOD AND PURPOSE OF DATA PROCESSING

LEGAL BASIS

The legal bases on which the processing of common data is based, according to Article 6 of the GDPR Regulation, are:

- Contract
- Law

Pursuant to articles 9 and 10 of the GDPR Regulation, if they are conferred to the Data Controller, data that can be classified as "special categories of personal data" and "personal data" related to criminal convictions and crimes", these may only be processed with a free and explicit consent, expressed in a written form at the bottom of this document.

The provision of data is mandatory for all that is required by legal and contractual obligations and therefore, any refusal to provide in whole or in part may result in the impossibility of providing the requested services.

CATEGORIES OF RECIPIENTS

Notwithstanding to communications carried out in fulfillment of legal and contractual obligations, all data collected and processed may be communicated exclusively for the purposes specified above the following categories of recipients:

CATEGORY OF PERSONAL DATA

According to what is stated in Article 14 of the GDPR Regulation, as the data were not obtained from the interested party, the categories of personal data being processed are reported:

RIGHTS OF THE INTERESTED PARTY

In accordance with European Regulation 679/2016 (GDPR) and the national legislation in force, the interested party may, according to the methods and within the limits established by current legislation, exercise the following rights

- request confirmation of the existence of personal data concerning him (right of access of the interested party art. 15 of the EU Regulation 679/2016);
- know its origin;
- receive intelligible communication;
- have information about the logic, methods and purposes of the processing;
- request its updating, rectification, integration, cancellation, transformation into anonymous form, the blocking of data processed in violation of the law, including those no longer necessary to pursue the purposes for which they were collected (right of rectification and cancellation articles. 16 and 17 of the EU Regulation 679/2016);
- right to limit and/or object the processing of data concerning it (art. 18 of the EU Regulation 679/2016);
- right to withdraw;
- right to data portability (art. 20 of EU Regulation 679/2016);
- in cases of processing based on consent, receive your data provided to the owner, in a structured and readable form by a data processor and in a format commonly used by an electronic device:
- the right to present a complaint with the Supervisory Authority (right of access of the interested party art. 15 of the EU Regulation 679/2016).
